Token Types

Standard Token:

A type of token that is generated with a limited supply and a fixed number of decimals. It does not have any taxes and can be used for trading.

The supply rate cannot be changed later, taxes cannot be added, and there are no whitelist and blacklist features. If you need any of these features, please check other token types.

Burnable Token:

A type of token that is generated with a limited supply and a fixed number of decimals. In a Burnable Token, it is possible to burn any amount of tokens you want at any time.

The supply rate cannot be changed later, taxes cannot be added, and there are no whitelist and blacklist features. If you need any of these features, please check other token types.

Mintable Token:

A type of token that is generated with a limited supply and a fixed number of decimals. In a Mintable Token, a new supply can be created, and the token supply can be increased if desired.

The supply rate cannot be changed later, taxes cannot be added, and there are no whitelist and blacklist features. If you need any of these features, please check other token types.

Deflationary Token:

A type of token that is generated with a limited supply and a fixed number of decimals. The Deflationary Token allows you to collect a tax for each transaction made with the token. A tax can be added to each transaction at a rate determined by you, and you can change this tax rate via the manage panel whenever you want.

The supply rate cannot be minted again, but you can burn any amount of tokens you want at any time. In the Deflationary Token, you can add a blacklist feature.

Superdeflationary Token:

A type of token that is generated with a limited supply and a fixed number of decimals. There are several taxes that you can use or disable in every transaction.

You can add a tax or add liquidity to each transaction at a rate determined by you. You can automatically distribute to holders or automatically burn tokens at a rate you set. The supply rate cannot be minted again, but you can burn any amount of tokens you want at any time. You can add whitelist and blacklist features.

Pro Token:

A type of token that is generated with a limited supply and a fixed number of decimals. There are several taxes that you can use in every transaction.

You can set different tax rates for BUY and SELL transactions. You can add a tax or add liquidity to each transaction at a rate determined by you. You can automatically distribute to holders or automatically burn tokens at a rate you set.

The supply rate can be minted or burned. You can add whitelist and blacklist features.

VIP Token:

All features of other token types are available. You can update all features via the manage panel at any time. You can use independent taxes for BUY and SELL transactions while making tax-free selections for TRANSFER transactions.

You can manage all token types via the manage panel.

Token Variables:

Token Name: The name that should be given to the token. Spaces can be used. It is recommended that it not be too long.

Token Symbol: The symbol to be used for the token. It should not exceed 4 or 5 characters. Upper or lowercase letters can be used.

Decimals: It can take a value between 1-18. 9 or 18 are recommended based on your needs.

Supply Amount: The supply amount for the token.

Token Owner: The wallet address that will be the contract owner for the token.

Router Address: The Router address for the DEX where liquidity will be added. It can be obtained from the blockchain or DEX documentation. Several important Router Addresses have been shared on our site.

DEV Address: The developer wallet information. The "Developer Fee" tax will be transferred to this wallet. It can be updated via the "Manage Panel".

Developer Fee: The tax rate that will be transferred to the "DEV Address" specified via the "Manage Panel".

Liquidity Fee: The tax rate that will be automatically added to the liquidity for each transaction on the DEX. It can be updated via the "Manage Panel".

Holders Fee: The tax rate that will be automatically distributed to token holders for each transaction. Taxation occurs with each transaction.

Burn Fee: The rate at which burning will automatically occur for each transaction.

BUY Tax: The tax rate that will occur for each buy transaction. It can be updated via the "Manage Panel".

SELL Tax: The tax rate that will occur for each sell transaction. It can be updated via the "Manage Panel".

Transfer Tax: The tax rate that will occur for each transfer transaction. It can be updated via the "Manage Panel".
